#### Release

In support of my child's security & protection, KidzBlock Learning Center will release a child only to parent(s)/guardian(s) or to a third parties I authorized below. Parents/guardians are required to present an up-to-date copy of any applicable Custody Order. Third party authorized as pick-up, or emergency contact person is subject to the subsequent rules:

- Two people other than the parents/guardians are required to be listed and assigned as emergency contacts by checking the emergency box for the designed person. Emergency contacts will be reached if parents/guardians cannot be contact.
- If the individual picking up is listed below, but does not pick up the child routinely, I will inform the center orally, in advance. Oral authorization is not allowed for any individual not listed on this form
- If the individual picking up is NOT listed below, I be required to inform the center in writing ahead of time via email or printed.
- Photo ID will be mandatory if the third party does not pick up the child habitually or is unfamiliar to the center staff.

### Walking Field Trip Permission

If the weather permits, I give authorization to my child, to attend and participate in walking field trips within the community to local parks and local business as a daily nature outdoor routine. The walks will be supervised by staff and a stroller will be used to move infants and toddlers.

For Preschoolers, Pre-kindergarten and school-age children may participate on bus trips or field trips outside our surrounding area. A separate Field Trip Authorization Slip, informing the activity, will be sent home for signature prior the event.





## Photography & Video Permission

KidzBlock Learning Center ensures that any use, exhibit, or distribution of photos or videos of children is done with care and caution. Children enrolled in KidzBlock Learning Center are photographed and videotaped on a daily basis.

Photos and videos could be shared with you and other parents via the KidzBlock Learning Center website, email, Brightwheel and our center board. For instance, they can be used to communicate and interact with parents by highlighting our daily curriculum while recording your children's growth.

Photos and videos can be used for other purposes, such as marketing, including printed or online. Furthermore, KidzBlock Learning Center holds all rights, title, and ownership in all of these materials and might even use and broadcast them in a variety of ways in its sole discretion.

- I provide KidzBlock Learning Center authorization to take photos and videos of my child and use these materials as mentioned above.
- I provide KidzBlock Learning Center authorization to take photographs and videos of my child for the sole purpose of documenting the curriculum, recording my child's growth and communication with me and other parents.

#### Child Illness

I will be contacted by KidzBlock Learning Center if my child becomes sick. Mostly, the center will have required me to pick up my child as rapidly as possible within 90 minutes at most.

However, my child must stay out of the center until he/she is symptom free for 24 hours, unless a doctors indicate via note that the child 1) not contagious; and 2) can participate in group care. As stipulated on KidzBlock Learning Center Family Guide Illness Policy section, parents must follow protocols for contagious illenesses.

### Children's Injuries

If my child suffers a minor injury while in care, I will receive an Incident Report detailing the event when I pick up my child describing the incident as well as a digital copy through BrightWheel Report Section. If the injury causes swelling on the face or head or needs medical attention, I will be notified right away.

If my child needs emergency medical attention, KidzBlock Learning Center will contact me or the authorized emergency contacts listed above (If parents/guardians cannot be contacted)

I give KidzBlock Learning Center permission to summon an ambulance to bring my child to the nearest hospital or medical center, or, if possible, to my chosen facility, for medical care.
